

Department of Human Physiology, Holy Cross College, Agartala, conducted a "ONE-DAY WORKSHOP ON INTELLECTUAL PROPERTY RIGHTS" on August 13th, 2024, in collaboration with the Institution's Innovation Council (IIC) and Internal Quality Assurance Cell (IQAC) of Holy Cross College, Agartala. The workshop aimed to provide participants with a comprehensive understanding of intellectual property rights, their significance in various industries, and the legal framework surrounding them. The event attracted professionals, students, entrepreneurs, and researchers interested in protecting their innovations and understanding the legal aspects of intellectual property. The resource person of this workshop is Dr. Sanchaita Rajkhowa, Assistant Professor, Centre for Biotechnology and Bioinformatics, Dibrugarh University. In total, 215 candidates have registered themselves as participants; out of them, a total of 175 participants participated, and they were from various Institutions in India and neighboring countries.

The training was formally started with a short introduction of the workshop by Dr. Sandeep Roy Sarkar, Assistant Professor and the senior most faculty, Department of Human Physiology, Holy Cross College, Agartala. Dr. Sushobhan Sengupta, IQAC Coordinator, Holy Cross College, Agartala, was kind enough to deliver an introductory message on IPR that was followed by a welcome address from respected Dr. Fr. Benny K. John, Principal, Holy Cross College, Agartala. Dr. Susmita Saha, Head of the Department, introduced the resource persons to the participants.

Dr. Sanchaita Rajkhowa provided an overview of the various forms of intellectual property, including patents, trademarks, copyrights, and trade secrets. The speaker also discussed the historical evolution of IPR and its relevance in today's global economy. This session focused on the patent system, covering the process of obtaining a patent, the criteria for patentability, and the importance of patents in encouraging innovation. The speaker highlighted the challenges of patent infringement and the strategies for protecting patent rights. The discussion also included the registration process, the legal protection of trademarks, and the significance of trademarks in building brand identity and consumer trust. Additionally, the session explored the complexities of copyright law in the digital era, including issues related to digital content, software, and online platforms. The speaker discussed the balance between copyright protection and the free flow of information.
